

Charge Type	Charges (exc. of Vat)	Description
Collection & Delivery	£1.50 per mile	This charge is applied for vehicle delivery & collections (each way)
Fuel Charges	AA National Average +25%	Charge to replace fuel if different from the initial supplied level
Abortive Delivery & Collection	£29.00 plus £1.50 per mile for the total distance travelled	To recover costs due to failed delivery or collection
AdBlue	£1.20 per litre	Charge to replace AdBlue if different from the initial supplied level
Waiting Time Charge	£25.00 for the first hour. Subsequent charges are calculated at £25.00 per hour in 15-minute intervals	Our charge for waiting to deliver/collect the vehicle to you where you are not available (for any reason whatsoever) to take delivery/collection of the vehicle at the Delivery Time or within 1 hour thereof.
Collision Damage Waiver (Camper Van Hire)	£12.50 per day	In the event of an own fault accident-causing damage to the vehicle or any third-party property the hirer is liable for a £1,000 excess. This liability can be reduced to £300 with the optional CDW that costs £12.50 per day. Please note the CDW does not cover the replacement or repair to the roof, undercarriage, windows, tyre damage, loss of keys or damage to the interior fixtures/fittings and equipment.
Valeting Charges	£75.00 plus additional charges if specialised cleaning is required	Valeting charge and charges for specialised cleaning is for vehicles that are outside of an acceptable standard.
Valeting Charge due to Smoke odour	£250.00	The cost of deep cleaning the vehicle from smoke odour. This excludes the cost of any replacement parts and/or materials
Fine Administration Fee	£30.00 plus the value of the fine incurred if paid by Autolease Ltd	Admin fees for processing a fine or making a representation regarding traffic violations
Returned Payment Charges	£30.00 admin charge for returned item	Administration fee for any payments due that are returned / bounced
Late Payment Charges	£30.00 admin charge for a payment that is greater than 6 days. Cancellation Charge (Successful)	£500.00	Where a cancellation has been successful with the supplying dealer, this fee will be charged
Cancellation Charge (Unsuccessful)	All rentals due, as set out in the Order Form	Where a cancellation has been unsuccessful with the supplying dealer (eg. Dealer has registered the vehicle and/or delivered the vehicle to Autolease Ltd
Lost Keys	Cost plus 10%	The cost of replacement key(s) and all associated costs such as reprogramming, vehicle recovery etc.
Missed Services	Cost plus 10% on all parts and labour. Further charges may apply to compensate in loss of Residual Value detailed by CAP Hpi	Charges applied where scheduled vehicle servicing has been missed due to negligence of the Lessee, and for the replacement of parts and Labour for additional maintenance required due to Schedule Servicing being missed
Damage repair charges	Cost plus 20% up to a maximum of £500.00	Administration charge applied in managing & processing all costs associated with damage repairs. This is for both repairs conducted "in life" and "end of life" of the rental
BVRLA VE103B Form	£25.00 per form	Document cost required to obtain authority to take a vehicle out of the UK
Excess Mileage	A mileage rate of 0.33pence per mile, or a residual shortfall based on CAP Hpi Valuation plus an administration fee of £250.00+ Vat.	Vehicles are not permitted to travel beyond the agreed mileage set out in the Rental Agreement and/or Rental Order. Where excess mileage does occur, either an excess mileage charge will be applied or, Autolease reserve the right to charge the hirer any residual value shortfall against the vehicle market value at the date the vehicle is returned to Autolease

Late Return Charge	0 > 7 Days = 100% of the rental 8 > 14 Days = 150% of the rental 15 > 21 Days = 200% of the rental 22 + = 300% of the rental	The charges applied to a rental that has not been returned on the agreed and/or due date
Tyre Charges	Cost of the tyre, and associated costs incurred in replacing the tyre + 10%	The cost applied to a tyre that has been damaged and/or punctured. Costs associated would include but not limited to items such as wheel valve and balancing, tyre disposal and call outs
Missing Items	Cost of the missing item including fitting and delivery / postage + 10%	The cost of any missing items not returned with the vehicle. This includes both fixed and loose items (Floor Mats, Camper Inventory, parcel shelf etc.)
